EXECUTIVE SUMMARY

This deliverable reports on the outcomes of the CENDARI transnational access programme. It includes a record of selection process and total number/duration of access visits in the programme, as well as user feedback on the impact of the access opportunities on their work.

The project made great efforts to ensure that the allocation of the funding was transparent and fair. It is for this reason that the project originally tasked its External Expert Advisory Board with the evaluation of applications, and asked all board members to score all applications, lest community biases and tendencies skewed applicant scores. In the course of the TNA programme, the project gradually strengthened the host institutional feedback as a way of supporting reviewers in their assessments, and ensuring a good match between fellow and host.

There were three (groups of) stakeholders in the TNA programme: the CENDARI project, the Fellows and the Hosts. At the end of the programme we may conclude that all stakeholders benefitted from the programme. The project received invaluable input from the fellows, the research projects and future careers of the fellows were given a tangible boost, and the hosts favourably commented on the impetus the programme gave to their staff, not in the least by expanding networks and opening up the opportunity for new collaboration.

Introduction

The CENDARI Visiting Research Fellows programme was managed by WP3 and aimed to support and stimulate historical research in the two pilot areas of medieval European culture and the First World War by facilitating access to key archives, specialist knowledge and collections in CENDARI host institutions.

The CENDARI project was specifically committed to hosting early career scholars who aim to apply digital humanities methods to their historical enquiry. The fellowships were particularly designed to support researchers from countries without equivalent facilities and early career scholars with limited access to these research infrastructures. The Fellowships were hosted by:

- Trinity College Dublin, Ireland (TCD)
- King's College London, UK (KCL)
- National Library of the Czech Republic, Czech Republic (NKP)
- Göttingen Centre for Digital Humanities, University of Göttingen, (GCDH/UGOE)
- Germany University of Stuttgart & Bibliothek für Zeitgeschichte, Germany (USTUTT)

PROCEDURE

In general, the process applied to the call was as follows:

- A Call for Applications was issued in autumn, deadline just before Christmas
- Eligibility Criteria and Award Criteria were advertised with the call (see appendix for the Calls for Applications)
- The External Expert Advisory Board (EEAB, see next page for the list of experts) and the hosts assessed the candidates
- EEAB, hosts and Project Management Board (PMB) held a meeting in March to allocate the TNA places
- The candidates were informed of outcome in March/April, non-successful candidates were provided with feedback and encouraged to apply to the next calls
- The candidates and their host agreed a suitable time for the study period

Eligibility Criteria

- Application complies with the Terms and Conditions and is complete
- Applicant is at PhD student level or above
- Applicant works or studies in an institution established in an EU
 Member State or associated state
- 4. Applicant must work/study in a country other than the country where the CENDARI host institution is established
- Research proposal is realistic and appropriate for the selected host institution(s)

Call for applications 2013

The Call for Applications to the CENDARI Transnational Access Programme for 2013 was advertised in October 2012 and the closing date for receipt of applications was 12th December 2012.

Twenty-three complete applications were received. The applications were assessed individually, against the eligibility criteria (see p. 3) by the host institution applied to. The results of these assessments were discussed and agreed during two Skype meetings on 17th and 19th December 2012, coordinated by the Consortium of European Research Libraries (CERL).

Seventeen applications were deemed eligible for assessment against the

Award Criteria by the CENDARI EEAB. Each member of the EEAB assessed the applicants individually between 29th of January and 25th of February 2013.

During the CENDARI annual meetings in Dublin on 7-8 March 2013, the TNA hosts, the PMB and the members of the EEAB met to discuss the scores assigned to each applicant. Based on the scores and the consensus reached among the panel, it was agreed to make an offer of seven fellowship places in 2013, two at KCL, GCDH/UGOE and TCD each, and one at USTUTT. NKP and USTUTT carried over their places to the 2014 and 2015 calls and the project team investigated how to increase the applications for these positions.

The panel discussed the issue of balance between the applications for each of the two CENDARI pilot areas; six fellowship positions for 2013 were allocated to WW1 historians, one fellowship position was allocated to a medieval historian. It was agreed that the dissemination in the next Call should seek to ensure that medieval researchers were reached and encouraged to apply. In addition, the fellowship places that were not filled in 2013 were made available in the following years, which would also redress the imbalance.

The EEAB reviewed the call process and asked for improved information about the project and the hosts, a time table that was more generous, refinement of the award criteria, the introduction of weighting of certain criteria, implementation of a quality threshold and the application of ranking by the prospective host institution, all of which were introduced in the next call.

CALL FOR APPLICATIONS 2014

The Call for Applications to the CENDARI Transnational Access Programme for 2014 was advertised in October 2013 and the closing date was 9th December 2013.

Nineteen complete applications were received. The applications were assessed individually, against eligibility criteria by the host institution applied to. In accordance with the eligibility criteria, seventeen applications were deemed eligible for assessment against the Award Criteria by both the host institutions and the CENDARI EEAB. Each member of the EEAB and representatives of the hosts assessed the applicants individually between 8th January and 28th February 2014.

During the CENDARI annual meetings

The Hague on 13-14 March 2014, the TNA hosts, the PMB and members of the EEAB met to discuss the scores assigned to each applicant. It was agreed by consensus that the two lowest scoring candidates (scores lower than 55 points out of 100) were removed from further consideration.

Based on the scores and the consensus reached among the panel, it was agreed to make a definite offer of seven fellowship places, two at TCD, KCL, GCDH/UGOE each and one at NKP. The meeting recommended that, subject to the availability of resources and agreement of the hosting institutions, two further fellowships could be offered. This was later confirmed as a possibility for TCD and the fellow took their place but it was not possible for KCL to facilitate a third fellow in 2014 but that they would do so in 2015.

NKP and USTUTT had remaining places from 2013 and 2014 and the panel suggested that a supplementary call should be published this year in both English and German, to seek applicants from the German-speaking research community to fill these places. One eligible application was received and was reviewed as per the same process as the other candidates in the 2013 and 2014 calls. The candidate, Dr Albina Moscicka, was awarded a place at USTUTT and she took up her fellowship in June 2015.

As in the previous year, the panel discussed the issue of balance between the applications for each of the two CENDARI pilot areas; four fellowship positions for 2014 were allocated to







WW1 historians, five fellowship positions were allocated to medieval historians, so that the 2014 programme successfully redressed the imbalance experienced in the 2013 programme.

CALL FOR APPLICATIONS 2015

The Call for Applications to the CENDARI Transnational Access Programme for 2015 was advertised in October 2014 and the closing date for receipt of applications was 15th December 2014. Twenty-six complete applications were received. The applications were assessed individually against the eligibility criteria by the host institution applied to.

Twenty-five applications were deemed eligible for assessment against the Award Criteria by the CENDARI EEAB and the prospective hosts. Assessment was carried out individually between 17th of December 2014 and 11th of February 2015. The EEAB, representatives of the PMB and the hosts met on 31st March 2015 during a skype call to discuss the scores.



It was agreed by consensus that the five lowest scoring candidates (scores lower than 55 points out of 100) were removed from further consideration. Based on the scores and the consensus reached among the panel, it was agreed to make a definite offer of nine fellowship places, two at TCD, KCL, GCDH/UGOE, USTUTT each, and one at NKP. The meeting recommended that, subject to the availability of resources and agreement of the hosting institutions, three further fellowships could be offered. This was later confirmed and the fellows took their places at KCL, GCDH/UGOE and TCD.

As in the previous year, the panel discussed the issue of balance between the applications for each of the two CENDARI pilot areas; seven fellowship positions for 2015 were allocated to WW1 historians, five fellowship positions were allocated to medieval historians.

Over the three years, 11 medievalists and 16 WW1 historians received a fellowship. As the National Library of the Czech Republic for most of the project's duration was closed for restauration (and, unfortunately, the National Museum in Prague, which might have served as an alternative resource for manuscript material was simultaneously closed), the availability of fellowships in the medieval fields was severely diminished and NKP was unable to take its full allocation of fellows. Fortunately, the other hosts in the project were able to offer extra positions in their institutions, so that in total 27 fellows received a grant through the CENDARI TNA programme.








DUTIES OF THE CENDARI FELLOWS

All CENDARI Fellows were expected to:

- Work within a clearly-defined programme of research activities which contribute to their overall research goals whilst utilising the collections and/or the knowledge infrastructure of the chosen CENDARI host institution
- Deliver at least one lecture, workshop, seminar or master-class relating to their research project at the host institution during the tenure of their fellowship
- Participate in a limited number of expert seminars and contribute, where appropriate and relevant, to the ongoing development of the CENDARI project and infrastructure
- Submit a short written report on their progress at the end of the fellowship
- Make their findings, where applicable, available to future users of the CENDARI enquiry environment
- Provide the CENDARI project Coordinator with one copy of any publication which results from the research undertaken at the host institutions
- Publish the results of their project through the appropriate channels, making reference to the support given by CENDARI and the EU
- Fellows will be expected to spend at least 3 days a week at the host institution to conduct research on their research project. Research at other institutions in the vicinity of the respective host is encouraged

RESULTS HOSTS QUESTIONNAIRE

The hosts were very pleased with the academic level of the fellow; they were solid and well-prepared, even if their knowledge of new computer based methods was on different levels. Most of the hosts found that although the fellow came to do their independent research, they all engaged in a close discussion of their methodological issues and opportunities with departmental staff. For the fellows this allowed them to establish new scholarly networks and gain new insights, offering the opportunity for new forms of collaboration and the development of new projects.

The hosts were generally satisfied with the level of facilitation that was required from them. Clearly, there was some effort required to gain an insight into the questions and topics relevant to the fellow's field, to the type of sources and materials that they wished to access, and to the research methods they wished to employ, in order to then partner fellows with the right people in the college or university departments. Even though for busy staff who are both teaching and conducting their own research sometimes it was sometimes difficult to spend the necessary time with the fellows, many of the hosts remarked how rewarding it had been for the academics engaging with the fellows. Many of the fellows presented a seminar or a class about their research topic.

It was too difficult in most cases to closely align the fellows' projects with core CENDARI project goals. Early fellows were a little disappointed not to be able to use any tools from CENDARI, whereas fellows who visited later into the project were able to engage to a much greater extent with the outputs from the project. For example, one of the 2015 Fellows used the note-taking environment, and another worked with the UI/UX expert to consider how the interface works.

The Hosts felt that the TNA programme had been very beneficial to the project as a whole, as the fellows shared their opinions of the developmental work with project, and contributed data and use cases, as well as outside opinions. In addition, the hosts benefitted, in that, in several cases, the fellows stimulated intensified interdepartmental collaboration in the host institution. Continued communication with the fellows has enriched scholarly networks, led to the development of new project plans, and the CENDARI project has benefit as many fellows joined the so-called Trusted Users Group that provides the project with feedback on the VRE and its tools.

As always there are some lesson learned and recommendations for future TNA programmes:







- Ensure that the visits of the fellows are tied in with teaching semesters when academic staff are available for consultation.
- Allow for greater advance planning to get dates in diaries and to gain a clear understanding of the research questions and topics of interest
- Manage expectations about the extent to which the fellows will be able to engage with the project and the nature of that engagement.

RESULTS TNA FELLOWS QUESTIONNAIRE

The TNA Fellows Questionnaire was shared with all 28 Fellows. At the time this report was written, nine of the 2015 Fellows had yet to complete (or even start) their placements. Twelve fellows who had completed their visit, and one fellow who would undertake her visit at the end of 2015, filled in the questionnaire.

Five fellows indicated that they mainly used the host's collections, four mostly received tutoring and four indicated that it was a combination of both.

They all indicated that their research had benefitted from taking part in the Transnational Access programme, for a variety of reasons:

- Their research will be published in A-rated journals
- They were introduced to new tools and technologies
- They gained a much better understanding of tools and technologies
- They felt the programme had fostered collaboration
- They felt their methodology and research methods had been firmed up
- They valued the un-interrupted study time the programme offered

The programme would 'possibly' help the careers of seven fellows and had already had a positive effect on the career of six fellows, for example because they had received a promotion or an award, had been invited to present at prestigious international events, had been invited into new projects, and had started to work with new technologies that speeded up their research.

Nine of the fellows rated the level of supervision as just right, one fellow (at GCDH) rated the level of supervision as excellent, three fellows gave no response or indicated that the question was not relevant in their context. Most of the fellows (nine out of thirteen) are still in communication with members of staff at the host institutions and their communications take either the form of reflection on trends in the field, possible new projects or further mentoring.

In general we can conclude that the TNA Scholars found that taking part in the TNA programme expanded their scholarly network, introduced them to new methodologies and tools (e.g. Python), and that it helped their careers in terms of gaining promotions and generating follow-up projects.

Evaluation of the CENDARI Transnational Visiting Scholars programme

Response from Trinity College Dublin

Two questions about the programme as a whole, and five for each of the visiting scholars:

a) Was the level of supervision and facilitation that you had to offer more or less than you expected? Any lessons learnt you want to share?

Yes, though I would have liked to have been able to give more. That said, to do so would have taken up a lot of time and effort, not necessarily in line with the goals of the rest of the project.

b) In your opinion, how did the work of the visiting scholars benefit the CENDARI project as a whole?

They added a lot more than I expected: they used some of our tools and data, they gave us opinions of the developmental work, they brought us data and use cases and outside opinions. All of this was of value.

2. Did the fellow make the most of their time with you? If not, what would you have expected the fellow to do more?

I felt the Fellows by and large did what they came to do - largely, however, this was independent research. So they made the most of their time, but it was too difficult in most cases to closely align their projects with core project goals.







3. Did they concentrate on using your collections or did they mainly receive tutoring (e.g. taking classes and engaging in academic exchange on the research topic)?

More the latter, but it was a lot more about networks and insight than about specific skills. For some, it was DH 101 and what this might mean for your project. For others, they walked away part of new scholarly networks and grant proposals. And everything in between.

4. Was the candidate of the academic level that you had expected? (e.g. more advanced, as expected, less advanced than expected)

I felt they were all very solid. Some had more ambitious projects than others, but all were well prepared for what they set out to do.

5. Are you still in communication with the visiting scholar – in what way? (e.g. scholar is taking further tutoring, regular exchange of ideas, will return to use collections, etc.)

I think many of them are now in the TUG, and there are some we keep in touch with, though I would not say there are strong ongoing collaborations









Evaluation of the CENDARI Transnational Visiting Scholars programme

Response from King's College, London

Two questions about the programme as a whole, and five for each of the visiting scholars:

a) Was the level of supervision and facilitation that you had to offer more or less than you expected? Any lessons learnt you want to share?

It varied according to the fellow. In all cases it was less a case of providing supervision and more of discussing their research and identifying where digital humanities methods, approaches and technologies might assist in their research and partnering them with the right people in the Department or elsewhere in the College. We also found that assisting in providing access to other libraries (the British Library for instance) was important. In some cases these discussions were very stimulating for all concerned, in others rather less so. The key lesson learned is that it is important for the period of the Fellowship to be tied in to teaching semesters. This ensures that Fellows are able to take classes if they wish and also to speak to teaching staff who will be in the Department on their teaching days. We found that the Fellows who visited over the summer were unable to take advantage of classes and that many of the staff members they wished to engage with were either away doing research or taking their annual holiday.

b) In your opinion, how did the work of the visiting scholars benefit the CENDARI project as a whole?

They did in so far as the Fellows provided a useful, and in many cases stimulating, insight in the questions and topics relevant to the field, to the type of sources and materials that they wished to access, and to the research methods they wished to employ. We were able to feed this into the thinking around the knowledge environment and the discussions on the overall portal and note taking environment. Inevitably, the Fellows who visited later into the project have been able to engage to a much greater extent with the outputs from the project, for example, one of the 2015 Fellows is using the note-taking environment, and another is working with the UI/UX expert to consider how the interface works. The key lesson learned here is to manage expectations about the extent to which the Fellows will be able to engage with the project and the nature of that engagement. Our early visitors were a little disappointed not to be able to use any tools from CENDARI but were very helpful in working with us to understand what might help them with their work.

2. Did the fellows make the most of their time with you? If not, what would you have expected the fellow to do more?

On the whole yes, although the Fellows who visited over the summer neither benefited themselves or the Department to the extent that we had hoped due to the timing. I would not recommend offering Fellows a summer visit in future projects. All the other Fellows made the most of their time in the Department by engaging with academic and research staff, attending departmental meetings, and taking advantage of the libraries and archives available to them in London.

3. Did they concentrate on using your collections or did they mainly receive tutoring (e.g. taking classes and engaging in academic exchange on the research topic)?

The primary purpose of their visit was not to use our collections, although at least two Fellows used collections in the King's College London Archives, but was instead to take advantage of the academic expertise in digital humanities methods and approaches. The primary method of engagement was scholarly exchange with some of the Fellows sitting in on MA lectures and seminars. By and large this was very successful and interesting both for the Fellow and for the academics. However, it is also very time consuming and for busy staff who are both teaching and conducting their own research sometimes difficult to spend the necessary time with the Fellows. In the future I would advise greater advance planning to get dates in diaries and to have a wider understanding of the research questions and topics of interest.


4. Was the candidate of the academic level that you had expected? (e.g. more advanced, as expected, less advanced than expected)

All were at the level expected and were interesting and intellectually stimulating colleagues to host in the Department. Each Fellow was asked to give a seminar which all did apart from the summer visitors in 2014 where it wasn't possible to find a date when enough staff and fellows would be around.

We remained in touch with the 2013 visitors for a while although this has lessened as time passes by. The Fellows who visited in 2014 did not make much impact on the department and no further contact has taken place. The current Fellows are most likely to stay in touch with the networks they have established during their visit and this may well lead to future collaboration.









Evaluation of the CENDARI Transnational Visiting Scholars programme

Response from Göttingen Centre for Digital Humanities (GCDH)

Two questions about the programme as a whole, and five for each of the visiting scholars:

a) Was the level of supervision and facilitation that you had to offer more or less than you expected? Any lessons learnt you want to share?

Cendari fellows enrich the spectrum of computer based research in the humanities at Göttingen. Especially in the history department digital humanities is still not a common approach. The collaboration with colleagues at the GCDH worked well. Room, talks, atmosphere were great. However, the collaboration with colleagues from the history department could be improved. Lesson learned is simply to integrate more those colleagues who are sceptical on digital humanities. Cendari fellows are a good 'bridge' between the still separated worlds.

b) In your opinion, how did the work of the visiting scholars benefit the CENDARI project as a whole?

They explored and used tools from CENDARI, got often a better sense what is possible with computer based methods and discussed their data and finding in our regular workshops at the GCDH. It all enriched research and learning at the GCDH

The fellow worked most of their time at the Centre, not especially with me, simply because I am not expert in their field. Some get in good contact with specialists from their own field. All visiting scholars looked for a close discussion of their methodological issues and opportunities.

Each visiting fellow gave at least one public presentation, some joined classes or the summer schools we run and/or discussed closely their research project with DH-experts at the GCDH. They all want to learn and to improve what they are doing.

The level was of course different, all are advanced in their historical research field. The knowledge of new computer based methods was on different levels.

Yes, with some of them, we are still in contact, but not with all.

Response from University of Stuttgart

Two questions about the programme as a whole, and five for each of the visiting scholars:

a) Was the level of supervision and facilitation that you had to offer more or less than you expected? Any lessons learnt you want to share?

The present fellows (Elli and Martina) just arrived in early October. Therefor we are still in the middle of the programme. Generally it can be said that the level was as expected despite the fact that fellows were/are very different in their respective approach (Bogdan and Albina more technically orientated, Elli and Martina more historically).

b) In your opinion, how did the work of the visiting scholars benefit the CENDARI project as a whole?

All fellows adopted and followed a transnational approach which really fits the needs of CENDARI. We presume that this will be an ongoing process that helps to establish CENDARI especially in Eastern Europe. In this respect Bogdan (Serbia) and Albina (Poland) provided some interesting data / prototype.

CENDARI Visiting Research Fellowships Call for 2013 Fellows

Introduction

The CENDARI project is a four-year collaborative research infrastructure project aimed at integrating digital archives and resources for medieval and modern European historical research. The focus is on two pilot areas for research: the First World War and medieval European culture. The project is funded by the European Commission's Seventh Framework Programme for Research. More information can be found at www.cendari.eu.

CENDARI Visiting Research Fellows Programme Summary and Objectives

CENDARI fellowships will be available in a number of the partner institutions. These visiting research fellowships, which are funded by the European Union's 7th Framework Programme for Research, are intended to support and stimulate research relevant to the objectives of the CENDARI project and its infrastructural host institutions by facilitating international access to key archives, specialist knowledge and collections in the partner institutions. In particular, the CENDARI project is committed to hosting early career scholars who aim to apply digital humanities methods to historical enquiry in the areas of medieval European culture and the First World War, and to ensure this research is integrated through the CENDARI research infrastructure. The fellowships are particularly designed to support researchers from countries without equivalent facilities and early career scholars with limited access to these research infrastructures. This Call is the first in a series of three annual calls for fellowships by the Cendari project.







The following CENDARI partners are offering two fellowships each for 2013 on a competitive basis:

- Trinity College Dublin, Ireland
- King's College London, UK
- National Library of the Czech Republic, Czech Republic
- University of Göttingen, Germany
- University of Stuttgart and Bibliothek fuer Zeitgeschichte, Germany

The descriptions of the above institutions are included in Annex 1.

CENDARI visiting research fellowships include a stipend for housing and living expenses as well as travel to and from the inviting institution. Details of the stipends available at each institution are included in Annex 1. Recipients will be responsible for securing visas, where necessary. Fellows will have access to the research infrastructure of the respective CENDARI partner institution including access to a workspace and a networked computer. The length of the researcher's stay will be from 8 to 12 weeks, but the fellow may extend the stay at his/her own expense and in accordance with the regulations of the host institution and visa regulations.

Duties of the CENDARI Fellows

All CENDARI Fellows will be expected to:

- Work within a clearly-defined programme of research activities which contribute to your overall research goals whilst utilising the collections and/or the knowledge infrastructure of the chosen CENDARI host institution
- Deliver at least one lecture, workshop, seminar or master-class relating to their research project at the host institution during the tenure of their fellowship
- Participate in a limited number of expert seminars and contribute, where appropriate and relevant, to the ongoing development of the CENDARI project and infrastructure
- Submit a short written report on their progress at the end of the fellowship
- Make their findings, where applicable, available to future users of the CENDARI enquiry environment
- Provide the CENDARI project Coordinator with one copy of any publication which results from the research undertaken at the host institutions
- Publish the results of their project through the appropriate channels, making reference to the support given by CENDARI and the EU







 Fellows will be expected to spend at least 3 days a week at the host institution to conduct research on their research project. Research at other institutions in the vicinity of the respective host is encouraged

Time Period for the Fellowships

Applicants are asked to indicate three potential start dates and the proposed duration of their research period on the application form. The start and end dates of the fellowship will not be finalised until agreed between the successful applicant and the relevant host institution.

Application Process

All application materials must be submitted in English and via email to <u>info@cendari.eu</u>. The application must include the following:

- A completed application form (see Annex 2).
- A curriculum vitae (maximum 2 pages).
- A proposal (1,500 words maximum) describing the research activities that the applicant plans to undertake during the term of the fellowship and how this research fits into the overall objectives of their own research. The proposal should include a work plan and list of the expected outputs from the stated research activities, outlining the relevance of the proposal to CENDARI, as well as an explanation of which institution the applicant wishes to apply to and why this choice fits the chosen research topic. CENDARI reserves the right to propose an alternative institution for applicants.
- Name and contact details for a referee who is familiar with the applicant's work and may be contacted directly by CENDARI.
- In the case of applications by Ph.D. students, the application should include a letter of recommendation from their supervisor

The closing date for receipt of applications is 12th December 2012. All applications should be sent by email to info@cendari.eu with the title "CENDARI Fellowship 2013" in the email title line. All applications received before the deadline will be acknowledged by return email. If you do not receive an acknowledgement email within two working days of submission of your application, please contact us immediately.

Trinity College Dublin – Trinity Long Room Hub

Trinity College Dublin (TCD) is a research-led university in the centre of the city of Dublin where historic buildings sit adjacent to cutting edge research facilities in the areas of Arts and Humanities, Sciences and Engineering. Trinity is a university of distinguished tradition, and one that is focussed on achieving substantial research achievements in the area of Arts and Humanities.

The TCD Library is one of the largest in Europe, with a bookstock of over 4.25 million volumes and extensive collections of manuscripts, maps and music, having been built up since the end of the sixteenth century. There is a collection of some 25,000 core academic journals available online in full text, along with key discovery tools and over 200,000 electronic books. As a Legal Deposit library, it enjoys the privilege of receiving all Irish and UK publications – a right it has had since 1801. Completed in 1732, the Old Library building contains the Departments of Early Printed Books, Manuscripts and areas open to the public: the Long Room, the Treasury, and the Colonnades Exhibition Area.

The Trinity Long Room Hub brings together expertise from the various disciplines of the arts and humanities as well as from computer science, linguistics, engineering and the library. Its award-winning facility on historic Fellow's Square houses a regular population of around 70 postgrads, postdocs, visiting scholars and professional staff, as well as a lively programme of small and large meetings, seminars and lectures. As a facilitating institute for advanced research in the arts and humanities, it also hosts a range of thematically linked initiatives, including Trinity's activities in Digital Humanities. University of Stuttgart

The city of Stuttgart in the south west of Germany is not just famous for housing the headquarters of international companies like Bosch, Daimler and Porsche, but also for scientific, academic and cultural institutions and achievements. It has a number of esteemed universities and some of the finest research institutes and libraries in Germany. The **University of Stuttgart** was founded in 1829, at the beginning of the industrial age in Europe. Today the university is a modern, achievement-orientated institution with a comprehensive range of subjects and currently more than 22.000 students. Despite its focus on engineering and technical disciplines, the University has an excellent reputation for architecture, arts and humanities, including History (the Historical Institute comprises Ancient, Medieval, Early Modern, Modern and Regional History as well as the History of Sciences and Technology). For more information visit the Institute's website: www.uni-stuttgart.de/hi The University and the Historical Institute will coordinate CENDARI fellowships for World War I researchers.

During the last twenty years Stuttgart has attracted numerous German and international historians with a particular interest in the history of the First World War. This is not least due to the existence there of the Bibliothek fuer Zeitgeschichte - BfZ (Library of Contemporary History), one of Germany's leading research libraries for 20th century history and politics, specializing among others in the history of both world wars. The BfZ is part of the Württembergische Landesbibliothek (Wuerttemberg State Library), Germany's fourth largest library, with currently more than 5,6 million media items. These are held ready in its stacks and reading rooms for research, teaching, further vocational training and general education. The BfZ alone holds approx. 380.000 books and 450 periodicals. Besides, the BfZ comprises a great number of archival collections relating to the war of 1914-1918: an extensive photographic collection with approx. 30.000 amateur and professional photographs, numerous political and military (wall) posters and pamphlets including leaflets dropped from aeroplanes during the war and a map collection comprising more than 7.000 topographic and military maps with an emphasis on the western front line. Unique in its size is a collection of letters, postcards and other autobiographical material (also private war diaries) containing at present more than 135.000 letters to and from the fronts from both world wars. This collection of war-related Ego-documents is now one of the most soughtafter archival collections for the new cultural representation (Kulturgeschichte) of the Great War. The collections of the BfZ are of particular interest for students and post-docresearchers with a special interest in the histories of mentalities (Mentalitätsgeschichte), everyday history (Alltagsgeschichte) and the visualization of the war. Besides the Library of Contemporary History Stuttgart hosts a number of other archives, libraries and museums containing special collections that should be of interest to World War-I-researchers. Among these are the military records of the **Württembergische Hauptstaatsarchiv** (Wuerttemberg State Archive), markedly for the Wuerttemberg Army, the church collections of the **Landeskirchliches Archiv** (Protestant Church Archive), the municipal collections of the **Stadtarchiv** (City of Stuttgart Archive), as well as the collections









of **Haus der Geschichte** (Baden-Wuerttemberg Museum of History). In the vicinity of Stuttgart resides the **Deutsches Literaturarchiv** (German Literature Archive) in Marbach, which holds the largest archival collection of German-speaking poets and writers in the 20th Century.

Národní knihovna České republiky National Library of the Czech Republic

The **National Library of the Czech Republic** (NKP) is one of the eldest Czech public libraries with collections of more than 6 million volumes, having irreplaceable cultural value for many cultures. As a leading institution in preservation and access to documentary heritage is also a coordination centre for research/development national programs. It is one of the technologically most advanced national libraries in Europe as demonstrated in the recently published TEL-ME-MOR analysis of CENL member libraries. It has participated in several EU/international projects (e.g. FPs – MASTER, VICODI; eContentPlus – ENRICH; Eureka – ECH:TOPICC; Culture2000 – COMTOOCI; Culture2007 – REDISCOVER, EMBARK). It is a professional, methodical, consultancy and coordination centre for work with historical and music collections on the territory of the Czech Republic; in the fields in question it guarantees international cooperation. Within the framework of legislative and normative process, it submits observations, initiatives, proposals and recommendations concerning cultural heritage. It cooperates with libraries, institutions and professional establishments both in the Czech Republic and abroad. It is responsible for the participation of the NKP in joint projects and for complying with particular agreements concerning historical and music collections. Within the scope of its professional competence, it provides coordination, methodical, advisory and consultancy services; authorized to do so within the scope of their competence are also the individual subordinate departments. It participates in research and development. Basic units are Department of Manuscripts and Early Printed Books and Section of Manuscriptorium.

Manuscripts and Early Printed Books: It acquires, manages, and provides access to the NL historical collections. It builds up and manages a reference library and reference collections of the department in question. It is responsible for processing and editing of the National Retrospective Bibliography ("Knihopis" in Czech). Within the scope of its competence, it is involved in professional publishing and exhibition activities of the NKP. It participates in creating virtual research environment for work with historical collections. It is engaged in research and development in the field of history of book culture and cultural heritage. It issues certificates required for export of objects of cultural value from the sphere of book culture.

Manuscriptorium: It coordinates the content of the Manuscriptorium Digital Library, it prepares the conception and strategy of its further development. It coordinates the creation









of a virtual research environment for work with historical collections. It takes part in both national and international programmes and projects of digitizing historical collections. It cooperates in providing access to and research in literary cultural heritage.

CENDARI fellowships are available for periods of 10 weeks duration from 1st July 2013 to 6th September 2013. Fellows will be expected to spend a minimum of 3 days a week at the host institution to conduct research on their research project. CENDARI Visiting Research Fellowships Call for 2014 Fellows

Introduction

The CENDARI project is a four-year collaborative research infrastructure project aimed at integrating digital archives and resources for medieval and modern European historical research. The focus is on two pilot areas for research: the First World War and medieval European culture. The project is funded by the European Commission's Seventh Framework Programme for Research. More information can be found at www.cendari.eu.

CENDARI Project

The CENDARI Project is a four-year project funded by the European Commission to integrate digital archival resources for medieval and modern history. The project is being delivered by a consortium of 14 partners from across Europe, including Ireland, the UK, Germany, France, Italy, the Netherlands, the Czech Republic and Serbia. The project has an overall budget of €6.5M, and is coordinated by Trinity College Dublin.

CENDARI involves a broad collaboration between historians, research infrastructures, and technical experts, many of whom have already been working toward the consolidation of e-humanities infrastructure in the context of DARIAH, the EU's Digital Research Infrastructure for the Arts and Humanities. All are contributing building blocks to the construction of the CENDARI enquiry environment, an innovative system that will change the way we view historical research.







The platform will provide centralised access to previously fragmented European information resources, such as archives and libraries. The advent of digitisation programmes already enables scholars to access extensive collections online, but in CENDARI, the emphasis will be on drawing together material, from disparate sources and in various digital formats, into a consolidated bespoke environment for research.

Building digital bridges between highly dispersed archives and collections is, however, merely the starting point for the partners' joint endeavour. The new platform will be equipped to support transnational and comparative approaches across disciplines, locations and modalities of scholarship, creating a space where key aspects of our shared history can be placed in a truly European context. As one of two case studies selected for the purposes of the development, the team will approach an area of study where the fragmentation of sources has been particularly problematic: research into the First World War, a pan-European event which remains insufficiently explored as such.

Powerful tools and services will underpin this interactive search environment. Proposed functionalities include multilingual search operations across heterogeneous data sets, indexes of named entities (people, places or events), personalisation features, shared research and teaching spaces, and annotation trails inviting users to add intelligence to the system.

Other activities will focus on introducing new paradigms for the exploration of patterns and on developing applications that will use a visual and semantic palette to highlight geopolitical changes, as reflected in shifting borders, the emergence and decline of communities and political entities, and the related linguistic, cultural and economic realignments. These functionalities are of particular interest for studies into periods of rapid change, such as the First World War. The project's second case study, dedicated to creating an atlas of medieval culture, will also draw heavily on these advanced features.

CENDARI Visiting Research Fellows Programme Summary and Objectives

CENDARI fellowships will be available in a number of the partner institutions in 2014. These visiting research fellowships, which are funded by the European Union's 7th Framework







Programme for Research, are intended to support and stimulate research relevant to the objectives of the CENDARI project and its infrastructural host institutions by facilitating international access to key archives, specialist knowledge and collections in the partner institutions. In particular, the CENDARI project is committed to hosting early career scholars who aim to apply digital humanities methods to historical enquiry in the two pilot areas of:

- Medieval European Culture
- First World War

The fellowships are particularly designed to support researchers from countries without equivalent facilities and early career scholars with limited access to these research infrastructures. This Call is the second in a series of three annual calls for fellowships by the CENDARI project.

Introduction

The CENDARI project is a four-year collaborative research infrastructure project aimed at integrating digital archives and resources for medieval and modern European historical research. The focus is on two pilot areas for research: the First World War and medieval European culture. The project is funded by the European Commission's Seventh Framework Programme for Research. More information can be found at www.cendari.eu.

CENDARI Project

The CENDARI Project is a four-year project funded by the European Commission to integrate digital archival resources for medieval and modern history. The project is being delivered by a consortium of 14 partners from across Europe, including Ireland, the UK, Germany, France, Italy, the Netherlands, the Czech Republic and Serbia. The project has an overall budget of €6.5M, and is coordinated by Trinity College Dublin.

CENDARI involves a broad collaboration between historians, research infrastructures, and technical experts, many of whom have already been working toward the consolidation of e-humanities infrastructure in the context of DARIAH, the EU's Digital Research Infrastructure for the Arts and Humanities. All are contributing building blocks to the construction of the CENDARI enquiry environment, an innovative system that will change the way we view historical research.

The platform will provide centralised access to previously fragmented European information resources, such as archives and libraries. The advent of digitisation programmes already enables scholars to access extensive collections online, but in CENDARI, the emphasis will







be on drawing together material, from disparate sources and in various digital formats, into a consolidated bespoke environment for research.

Building digital bridges between highly dispersed archives and collections is, however, merely the starting point for the partners' joint endeavour. The new platform will be equipped to support transnational and comparative approaches across disciplines, locations and modalities of scholarship, creating a space where key aspects of our shared history can be placed in a truly European context. As one of two case studies selected for the purposes of the development, the team will approach an area of study where the fragmentation of sources has been particularly problematic: research into the First World War, a pan-European event which remains insufficiently explored as such.

Powerful tools and services will underpin this interactive search environment. Proposed functionalities include multilingual search operations across heterogeneous data sets, indexes of named entities (people, places or events), personalisation features, shared research and teaching spaces, and annotation trails inviting users to add intelligence to the system.

Other activities will focus on introducing new paradigms for the exploration of patterns and on developing applications that will use a visual and semantic palette to highlight geopolitical changes, as reflected in shifting borders, the emergence and decline of communities and political entities, and the related linguistic, cultural and economic realignments. These functionalities are of particular interest for studies into periods of rapid change, such as the First World War. The project's second case study, dedicated to creating an atlas of medieval culture, will also draw heavily on these advanced features.



I teach during term-time and thus would need to pursue a CENDARI fellowship during the summer months. Is this possible?

their research during the summer months and returned to the host institution during term time to deliver their fellowship lecture.
